Due to the recent fire in our area we wanted to take a moment and reach out and let you know of the efforts Old West and our community partners through the Fairgrounds Fire Relief effort is undertaking to minimize the impact of this devastating event.

We are working with community partners to create a donation fund and other resources to get relief funds and items to those folks who have been most affected; those residents of Grant County who have lost homes, have damaged property, and have been displaced. Old West will administer this account free of charge and will account for all monetary funds it receives to ensure donated funds are used as efficiently and effectively as possible.

For those of you wishing to donate locally, we are working with the Fairgrounds Relief Effort made up of a growing collaboration of concerned community individuals, partners, and agencies whose sole goal is to provide relief to victims as quickly as possible.

Old West has set up an account through which you may donate funds that will directly benefit those residents of Grant County who have been directly affected by the Canyon Creek Complex fire.

Donations can be made to a deposit account at Old West Federal Credit Union titled "Community Fire Relief Fund." You can fill out a form directing whether you want your donation to go to an individual or family, agency, or to a general fund to be administered by Old West.
