Section 4 Terms and Conditions

By applying for and accepting a loan payment under the Oregon Disaster Assistance Payment program, the applicant agrees to the following terms and conditions:

Section 4.1 ODAP Fund Distribution

The Oregon Department of Agriculture (ODA) will prioritize distribution of ODAP funds to applicants who demonstrate the highest percentage of loss reported and distribute funds to eligible applicants in a random lottery system until the exhaustion of all available funds.

Section 4.2 Forgivable Loan Terms and Conditions

- A. The Lending Institution (entity where application is submitted and processed) and the ODA have no obligation to disburse Forgivable Loan proceeds for the Forgivable Loan Amount unless all following conditions are met:

- a. The Acknowledgement and Certifications made in this application (below) by the applicant are true and correct on the date of disbursement as if made on such date.
 - b. The ODA has sufficient funds available and authorized for expenditure to finance the costs of the Forgivable Loan, including any related costs, within the department's legislative appropriation or limitation.
- B. The Lending Institution or the ODA may terminate this application with notice to the applicant if the Lending Institution or the ODA determines that the applicant has made a material misrepresentation or omission or committed fraud in the application.
- C. The laws of the State of Oregon (without giving effect to its conflicts of law principles) govern all matters arising out of or relating to this application, including, without limitation, its validity, interpretation, construction, performance, and enforcement. Any party ("Party" refers to Lending Institution, ODA, or applicant throughout this application) bringing a legal action or proceeding against any other party arising out of or relating to this application shall bring the legal action or proceeding in the Circuit Court of the State of Oregon for Marion County. Each party hereby consents to the exclusive jurisdiction of such court, waives any objection to venue, and waives any claim that such forum is an inconvenient forum.
- D. Notwithstanding the prior paragraph, if a claim must be brought in a federal forum, then it must be brought and adjudicated solely and exclusively within the United States District Court for the District of Oregon. This paragraph applies to a claim brought against the State of Oregon only to the extent Congress has appropriately abrogated the State of Oregon's sovereign immunity and is not consent by the State of Oregon to be sued in federal court.
- E. Nothing in this ODAP program gives or provides, or is intended to give or provide, to third persons any benefit or right not held by or made generally available to the public, whether directly, indirectly, or otherwise.
- F. ODA's obligations under the ODAP Program, including this application are subject to the Oregon Public Records Laws.

Section 4.3 Loan Forgiveness Determination

- A. All Forgivable Loans disbursed under the ODAP Program will be forgiven upon disbursement unless either or both of the following circumstances occur:
 - 1. The applicant receives USDA Farm Service Agency (FSA) disaster assistance approved under the Continuing Appropriations Act, 2022 (P.L. 117-43) for the calendar year 2021, including but not limited to payments under the Emergency Relief Program (ERP) assistance for crop producers and Emergency Livestock Relief Program (ELRP) assistance for livestock producers after the ODAP eligibility determination was made. The maximum loan amount will be recalculated if the applicant receives such federal relief funds, adding such federal relief funds to the applicant's 2021 farm or ranch income. The applicant shall repay the amount of the Forgivable Loan received that exceeds the recalculated maximum loan amount. No repayment shall be required, and the repayment amount will continue to be forgiven upon disbursement, if the repayment amount, together with any repayment amount pursuant to Section 4.3.A.2, is less than \$1,000.00.
 - 2. The applicant used an estimate for 2021 farm or ranch income, which was used to determine the Forgivable Loan amount disbursed, and the actual 2021 farm or ranch income according to filed tax forms exceeds the estimate. The maximum loan amount will be recalculated using filed tax forms' actual farm or ranch income. The applicant shall repay the amount of the Forgivable Loan received that exceeds the recalculated maximum loan amount. No repayment shall be required, and the repayment amount will continue to be forgiven upon disbursement, if the repayment amount, together with any repayment amount pursuant to Section 4.3.A.1, is less than \$1,000.00.

- B. On or before November 1, 2022, the applicant shall provide the Lending Institution with their federal award determination notice and their filed 2021 filed tax returns, as applicable, to allow the Lending Institution to perform the required recalculations provided above in Sections 4.3.A.1 and 4.3.A.2.. Failure to provide the required information will result in the Forgivable Loan not being forgiven and require the applicant to repay the entire loan amount.

Section 4.4 Loan Forgiveness and Loan Repayment Terms

A. The amount of an ODAP Forgivable Loan that is forgiven will be reported as income to the Internal Revenue Service via IRS Form 1099.

B. Any portion of an ODAP Forgivable Loan disbursement that is not forgiven shall be repaid by the recipient to the Lending Institution on or before June 1, 2023. Loans that are not timely repaid will be in default and may result in legal action by the State, and collection of any repayments will be handled by the Oregon Department of Revenue or other third-party collection agencies. Recipients in default will also become responsible for the payment of an additional collection fee of up to 20 percent of the amount owed.

I will also become responsible for payment of an additional collection fee of up to 20 percent of the amount owed if the loan is not repaid to the Lending Institution on or before June 1, 2023.

_____ I acknowledge, understand, and agree that failure to provide the applicable follow-up documentation (FSA award letter and 2021 filed tax return, as applicable) will result in the Forgivable Loan not being forgiven. Unforgiven loans are subject to full repayment, and failure to repay may result in full legal action by the State. Collection of any required repayments of disbursements may be handled by the Lending Institution, the Oregon Department of Revenue or other third-party collection agencies. I will also become responsible for the payment of an additional collection fee of up to 20 percent of the amount owed.
